**Acceptance of Proposals:** All artists will be notified by 19th March '21.

**Submission of Work:** Tuesday 30th March '21 - paintings/framed hanging works.

Wednesday 31st March '21 - 3D, sculptures, ceramics etc.

**Opens:** Saturday 3rd April - Closes Sunday 18th April '21.

**Guidelines & Procedures for Artists: (also see Consignment Agreement)**

- Nimbin Art Fair is open to all artists. Entry is free.
- All work entered must be original work, not previously exhibited in the Northern Rivers region & is exclusive to Nimbin Art Fair.
- All works entered must be for sale.
- All work must have the name of artist, title of work, medium & retail price attached to each work submitted
- All unsold work must be collected between 2pm - 4pm Sunday 18th April '21.

Artists must submit a Proposal telling us about themselves & describing their work.

**Proposals must include:**

- Artist bio
- Number of entries, title, size & medium of each piece.
- Retail price of each entry (ie: include The Gallery commission of  $33\frac{1}{3}\%$  - one third).
- Jpeg image of each entry if submitting electronically, or photos if submitting via hard copy.

Prior to submitting your Proposal please read carefully all details for submitting works.

Consider your insurance options & notify us early of any special requirements such as power outlet needed etc.

Proposals may be submitted electronically to [nimbinartistsgallery@gmail.com](mailto:nimbinartistsgallery@gmail.com) or handed in to Nimbin Artists Gallery, 49 Cullen St, Nimbin 10am - 5pm daily.

The Official Opening of the Nimbin Art Fair will be held on the evening of Friday 2nd April '21 for artists, friends & supporters of The Gallery. By invitation only. Your invitation will be available when submitting your work.

# Consignment Agreement

The Artist agrees to supply all work 'ready to hang' or 'display' & will be available exclusively to the Nimbin Art Fair from date of submission up to & including Sunday 18th April 2021.

All work will be for sale at the stated retail price unless other arrangements are made with the artist.

Nimbin Artists Gallery Inc. (the consignee) will pay the artist the retail price less 33 $\frac{1}{3}$ % (one third) commission\* on any work sold.

Notice of any sales, together with all payments due will be made available to the artist by 15th May '21.

**The Artist agrees/does not agree** that work(s) may be put on 'Lay-By' & paid in full by the end of the Nimbin Art Fair, (please indicate preferred choice).

**The Artist agrees/does not agree** that work(s) &/or images of your work may be used by The Gallery for Nimbin Art Fair publicity & promotion, (please indicate preferred choice).

**The Artist agrees/does not agree** to accept full responsibility for insurance of their work(s), (please indicate preferred choice).

**The artist agrees/does not agree** to give permission for Nimbin Artists Gallery to reduce the retail price on my artwork by up to 10% at any time throughout the Nimbin Art Fair exhibition period. Note: No offer of a price reduction will be made by Nimbin Artists Gallery/Nimbin Art Fair, any request for a price reduction must be initiated by the purchaser (please indicate preferred choice).

**Please note:** Insurance at all times remains the responsibility of the Artist.

No insurance is provided by Nimbin Artists Gallery Inc. or the Nimbin School of Arts.

Artwork is accepted only on the basis of 'all care, no responsibility' by Nimbin Artists Gallery.

All Artists, as consignor, must provide their ABN or an ATO 'Statement by a Supplier' form or a 48.5% withholding tax may be deducted from any payments due to the Artist.

\* **Commission charges**, as stated above, **may be reduced** by the Artist volunteering at Nimbin Art Fair.

Each full day worked reduces commission by 5%, to a maximum reduction to 20% for 4 full days or 8 half days.

A 'day' is 9.50am to 5.10pm. A 'half day' is 9.50am to 1.30pm & 1.30pm to 5.10pm.
